<p>Applies to:</p>	<p>The Giveaway is open only to Oregon residents 18 years of age or older at the time of entry but excludes any Giveaway Entities Personnel. <p>Are there criteria to be an Eligible Entrant?</p>	<p><b>Yes.</b> To be an <b>“Eligible Entrant,”</b> you:</p> <ul style="list-style-type: none"> <li>• Must be an Oregon resident aged 18 or older as of the time of entry;</li> <li>• Must not be Giveaway Entities Personnel;</li> <li>• Must properly complete an entry as described in these Rules; and</li> <li>• Must agree to be bound by these Rules.</li> </ul>
<p>Is a purchase or payment of any kind required in order to enter the Giveaway?</p>	<p><b>No.</b></p>

<p>What exactly is the Giveaway prize?</p>	<ul style="list-style-type: none"> <li>• One Eligible Entrant will be awarded the Giveaway prize.</li> <li>• The Giveaway prize includes: <ul style="list-style-type: none"> <li>○ pre-game courtside access for the winner and one (1) guest before the Men’s Basketball game between OSU Corvallis and Gonzaga University (currently scheduled for February 7, 2026) or another game determined by Sponsor (the “Game”);</li> <li>○ autographed basketball;</li> <li>○ four tickets to the Game; and</li> <li>○ Beavs Mobile Swag bag with goodies.</li> </ul> </li> </ul> <p>All prize details not expressly specified in these Rules will be determined by Sponsor in its discretion.</p>
<p>What is the Giveaway prize worth?</p>	<p>The approximate retail value of the Giveaway prize is \$[500]. Winner is not entitled to receive cash in lieu of the Giveaway prize. The Giveaway prize cannot be sold, but it may be gifted to another individual, provided (i) the winner notifies the Administrator of the winner’s desire to make such gift no later than January 27, 2026, and (ii) the Administrator approves such transfer in its discretion.</p>
<p>Will you have the right to use my name or likeness if I win?</p>	<p><b>Yes.</b> Except where prohibited by law, acceptance of the Giveaway prize constitutes permission for the Giveaway Entities to use the winner’s and winner’s guests’ names, photograph, likeness, statements, biographical information, and voice on a worldwide basis, and in all forms of media, in perpetuity, without further compensation.</p>

	<ul style="list-style-type: none"> <li>• Incomplete Entries will be disqualified. <b>“Incomplete Entries”</b> means (i) entries which are incomplete, illegible lost, late, misdirected, illegible, incomplete, invalid, unintelligible or damaged; (ii) entries submitted in a manner that is not expressly allowed under these Rules; or (iii) entries not submitted or received due to any technical error or failure, unauthorized human intervention, inaccurate capture or mis-entry of any required information, or the failure to capture any such information for any reason including programming or technical errors, or effects of hackers or failure of any electronic equipment, computer or cellular transmissions and/or network connections. Giveaway Entities Personnel are not responsible for Incomplete Entries.</li> <li>• Each Eligible Entrant must submit an entry on his/her own behalf. Any entry submitted on behalf of another individual or using another person’s name, email address or mobile number will be disqualified. An attempt by any entrant to obtain more than the stated number of entries allowed by using the same or multiple/different mobile numbers, email addresses, identities, or any other method will void all such entries and that entrant will be disqualified. <p>How is the winner selected, notified and verified?</p>	<ul style="list-style-type: none"> <li>• At the end of the Registration Period, a random drawing will be held by the Administrator within five business days to select one winner from among all eligible entries received.</li> </ul>

- The potential winner will be notified by Sponsor or Administrator via email and/or telephone and must, within the time period specified by Sponsor and/or Administrator, reply to the notification and execute and return all necessary releases and documents (if any) required by Sponsor and/or Administrator, such as a Declaration or Affidavit of Eligibility/Publicity and Liability Release.
