<p>What is the Premium Fan Experience prize worth?</p>	<p>The approximate retail value of the Premium Fan Experience prize is \$[500]. Winner is not entitled to receive cash in lieu of the Premium Fan Experience prize. The Premium Fan Experience prize cannot be sold, but it may be gifted to another individual, provided (i) the winner notifies the Sponsor of the winner’s desire to make such gift no later than May 8, 2026, and (ii) the Sponsor approves such transfer in its discretion.</p>

Premium Fan Experience Entities Personnel are not responsible for Incomplete Entries.</p> <ul style="list-style-type: none"> <li>• Each Eligible Entrant must submit an entry on his/her own behalf. Any entry submitted on behalf of another individual or using another person’s name, email address or mobile number will be disqualified. <p>How is the winner selected, notified and verified?</p>	<ul style="list-style-type: none"> <li>• At the end of the Registration Period, a random drawing will be held by the Sponsor within five business days to select one winner from among all eligible entries received.</li> <li>• The potential winner will be notified by Sponsor via email and/or telephone and must, within the time</li> </ul>

	<p>period specified by Sponsor, reply to the notification and execute and return all necessary releases and documents (if any) required by Sponsor, such as a Declaration or Affidavit of Eligibility/Publicity and Liability Release.
